### Capturing SDOH in EHRs

- [Capturing Social and Behavioral Domains and Measures in Electronic Health Records: Phase 1](#)

*Institute of Medicine (IOM), 2014*

In the first phase of a study by the IOM, a committee of experts identified the social and behavioral domains that are the best candidates to be considered in all EHRs; specified criteria that should be used in deciding which domains should be included; and identified any domains that should be included for specific populations or settings defined by age, socioeconomic status, race/ethnicity, disease, or other characteristics.

In the second phase of a study by the IOM, a committee of experts evaluated the measures of social and behavioral domains that most strongly determine health identified in phase 1. The report pinpoints 12 measures related to 11 of the initial domains and considers the implications of incorporating them into all EHRs.

## SDOH Data Sets and Indicators

The Data Set Directory contains an extensive list of data sets that include social determinants of health. The directory includes 12 domains of the social environment, a list of components within each domain, and data sources and variables that can be used to measure the components. Included data sets mostly contain information for metropolitan statistical areas.
